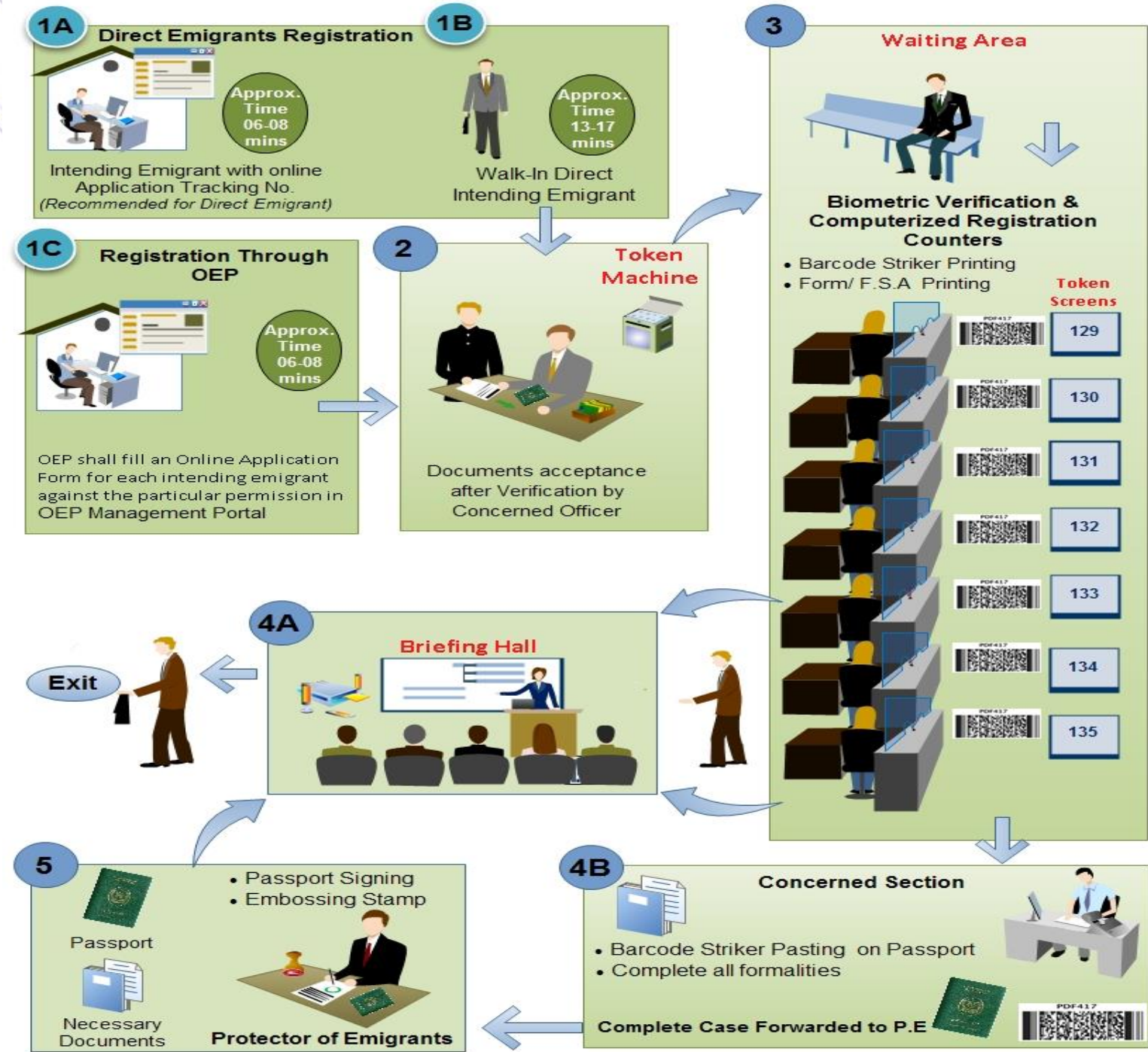

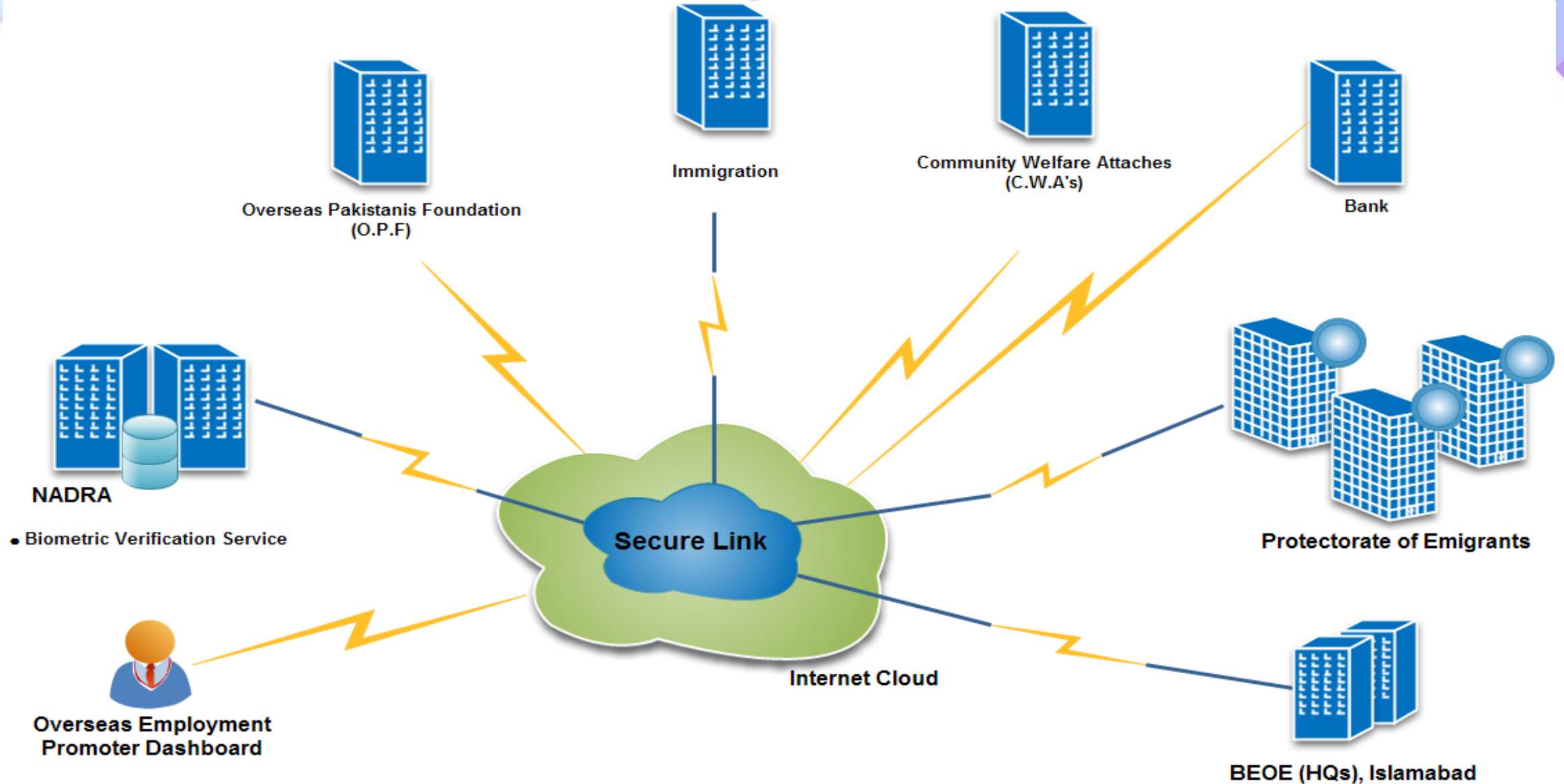
# Objectives

- Availability of complete and accurate information of Licensed Overseas Employment Promoters (OEPs) and their activities.
- Online Complaint Management System.

- Centrally deployed *Management Information System* (MIS), accessible via secure channel from PE Offices and within HQs.
- Digitization of OEP licences (2500 approx) and all their activities
